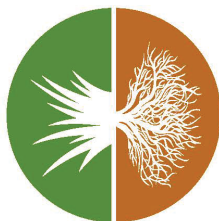

FOLIAR APPLICATIONS AND RATES

ORNAMENTALS/LANDSCAPES: Apply 1 to 2 quarts per 100 gallons of water for foliar sprays. Apply 2 to 5 ounces per gallon as a soil drench. Repeat applications as needed

TURFGRASS/SOD (Warm and Cool season): Apply 3 to 9 fl. oz. per 1,000 sq. ft. with sufficient water for coverage.

PRECAUTIONARY STATEMENTS

Avoid prolonged or repeated contact with eyes, skin, and clothing. Chemical goggles or a full face shield should be worn.
