## FOLIAR APPLICATIONS AND RATES

**ORNAMENTALS/LANDSCAPES:** Apply 1 to 2 quarts per 100 gallons of water for foliar sprays. Apply 2 to 5 ounces per gallon as a soil drench. Repeat applications as needed

**TURFGRASS/SOD (Warm and Cool season):** Apply 1 to 3 fl. oz. per 1,000 sq. ft. with sufficient water for coverage every 14-28 days.

**PRECAUTIONARY STATEMENTS** Avoid prolonged or repeated contact with eyes, skin, and clothing. Chemical goggles or a full face shield should be worn. To protect skin wear appropriate protective equipment, such as rubber or plastic aprons, rubber gloves, and boots. Avoid breathing mist or vapor. Keep containers closed.
