

FOLIAR APPLICATIONS AND RATES ORNAMENTALS/LANDSCAPES: Apply 1 to 2 pints per 100 gallons of water for foliar sprays. Apply 3 to 6 ounces per gallon as a soil drench. Repeat applications as needed

TURFGRASS/SOD (Warm and Cool season): Apply 1.5 to 3 fl. oz. per 1,000 sq. ft. with sufficient water for coverage.
