# HOUSE II : Infiltration Soil Surfactant and Water Conditioner

GENERAL INFORMATION: House II is a multi-component soil surfactant designed to reduce the surface tension of water and enhance infiltration. House II contains polyamino carboxylate, an amino-acid based cation sequestering polymer to condition spray tank water. House II is safe on all turf types, including premier turf for golf courses, athletic fields, tennis, lawn bowling, sporting fields as well lawns/landscape

### DIRECTIONS FOR USE:

#### Injection:

Apply 15-20 ounces per acre. If rate adjustments are needed, adjust up or down in 3 oz. increments to achieve desired results.

Spray: Apply 44-128 ounces in a minimum of 50 gallons of water for one acre. Apply monthly under normal conditions or every two weeks for more challenging soil conditions. Tank Mixing: House II may be tank mixed with other commonly used turf chemicals. If applicator is unfamiliar with the performance of this product in tank mixes under user's growing conditions, House II should be tested prior to large-scale application. Tank mixing this and other products is intended as a matter of convenience; this product is not intended to enhance the performance of other tank mixed components.

#### PRECAUTIONARY STATEMENTS



#### FIRST AID

**DISPOSAL:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best method of disposing container f allowed by law.
