



House II is a multi-chemistry soil surfactant and water conditioner. House II is formulated with both traditional soil wetting polymers along with powerful penetrants. House II will reduce the surface tension of water and facilitate enhanced irrigation infiltration and efficiency. Amino-acid polymer based sequestering agents are added to mitigate cations in tank mix water.

HOUSE II : Infiltration Soil Surfactant and Water Conditioner

GENERAL INFORMATION: House II is a multi-component soil surfactant designed to reduce the surface tension of water and enhance infiltration. House II contains polyamino carboxylate, an amino-acid based cation sequestering polymer to condition spray tank water. House II is safe on all turf types, including premier turf for golf courses, athletic fields, tennis, lawn bowling, sporting fields as well lawns/landscape

DIRECTIONS FOR USE:

Injection:
Apply 15-20 ounces per acre. If rate adjustments are needed, adjust up or down in 3 oz. increments to achieve desired results.

Spray: Apply 44-128 ounces in a minimum of 50 gallons of water for one acre. Apply monthly under normal conditions or every two weeks for more challenging soil conditions. **Tank Mixing:** House II may be tank mixed with other commonly used turf chemicals. If applicator is unfamiliar with the performance of this product in tank mixes under user's growing conditions, House II should be tested prior to large-scale application. Tank mixing this and other products is intended as a matter of convenience; this product is not intended to enhance the performance of other tank mixed components.

PRECAUTIONARY STATEMENTS

Harmful if swallowed, do not get in eyes or on clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse.

Personal Protective Equipment: Wear chemical resistant gloves, Long-sleeved shirt and long pants, and shoes plus socks.

FIRST AID

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition.

DISPOSAL: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best method of disposing containers if allowed by law. CLEAN UP: Rinse each spray tank out after each use and flush thoroughly.
